

Individual dental and vision premiums for Kentucky



For policies with effective dates of January 1, 2019 through December 31, 2019

Anthem Dental plans

The child/children rates shown in the charts below are defined as dependent children ages 0-20. Any enrollees age 21 and older use the adult rates, including dependent children over the age of 20. For a family, each adult (including dependent children ages 21-26) are rated first, and then up to the three eldest children ages 0-20. You will not be charged premiums for more than three children between the age of 0-20, even if there are more children covered by the plan.

Note that the charts below provide pricing for many of the most common family units. For other combinations, please talk to your broker or sales representative.
